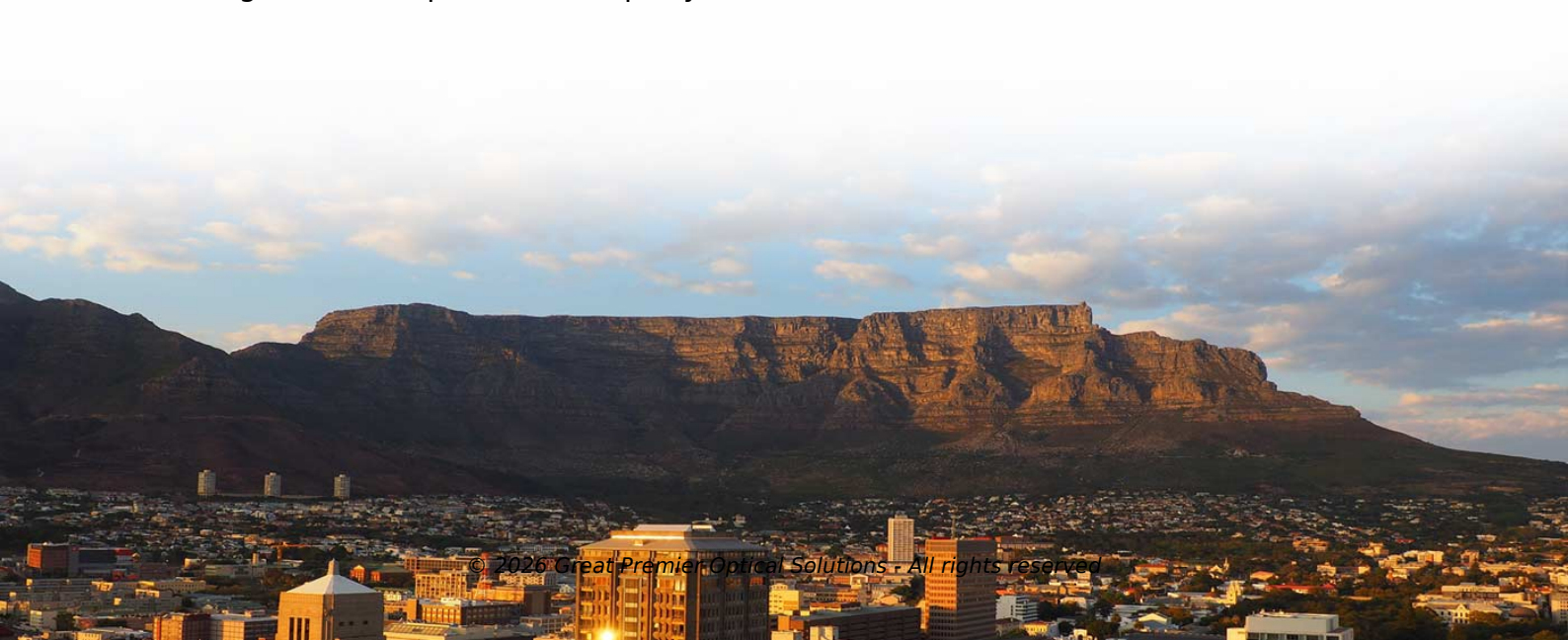


Does the optical module need UL certification



Overview

Since optical modules involve optoelectronic conversion, they must comply with UL 62368 -1 certification when exported to the U.S. Below is an overview of the testing requirements, required documentation, and certification process for UL 62368 certification of optical modules. UL is actually NOT mandatory, however, most retailers will demand UL certification before they buy products from manufacturers and not having the.
