

Who is responsible for the ownership of telecommunications towers



Overview

The companies that own and operate these towers, known as Tower Companies or TowerCos, are specialized entities distinct from the mobile carriers that use them. This business structure separates asset ownership from service provision, underpinning the rapid expansion of wireless. Over 65% of all cell towers in the United States are controlled by a handful of publicly traded companies, not the wireless carriers you expect. These owners are responsible for maintenance, upgrades, and compliance with regulations. We have revised our Antenna Tower Siting Procedures to ensure municipalities are involved early in the process. This Public Notice serves as a reminder that all parties to transfers of ownership of registered wireless communications towers must comply with the process set forth by the Wireless Telecommunications Bureau (Bureau) in a prior Public Notice. This reminder is necessary because of inconsistent.
